Analysis - Do you know that...?

...To incorporate a company in Timor Leste, there is already a centralized system — SERVE – which allows a more efficient and professional service to investors.

The minimum share capital for establishing a company (limited liability company) is 5.000 USD. New companies require a local representative (a Timorese citizen or a foreigner with work visa). It takes up to 2 weeks to incorporate a company and up to 4 days to register with the tax department.

The National Procurement Commission (NPC) of Timor Leste has recently launched a Public Tender for "Road Network **Upgrading Project**".

The Government wishes to upgrade Roads within the Districts and has support and finance from the European Union for this project.

The deadline for submitting tenders is 18 October 2016 and the candidates may request the Tender Documents in English version.

The National Procurement Commission also issued a Public Tender for the "Supply and Installation of National Connectivity Project VI".

This Tender is related to the implementation of Fiber Optic Network in 13 Districts.

Bids should be presented until 19 October 2016.


