## **Briefing** - A Proof of Democratic Maturity



The Democratic Republic of East Timor held its presidential elections on 20 March.

There are two aspects that deserve special attention in this elections: the high number of popular participation (which has become the rule in East Timor) and the tranquility that marked the whole pre-election and post-election process.

About 71% of the registered voters voted, demonstrating a clear vitality of the Timorese democratic and electoral system. A lesson on patriotism that would certainly embarrass many democracies with centuries of history, where citizens and politics are increasingly alienated.

But the best surprise - and, I dare say, the greatest success - of the elections was the peace and tranquility which was lived, from the presentation of the first candidacy to the presentation of the final results, certainly also due to the high level in which Candidates presented themselves and discussed their manifestos.

Democracy in East Timor has arrived and with each passing day it sedates more firmly.

We congratulate the President-elect, Francisco Guterres Lu Olo for the clear victory achieved and wish him the very best as he assumes office.

For the sake of democracy, for the benefit of the Timorese people.

## Analysis - Do you know that...?

### **Gambling Law**

One year ago the Timor Leste Government approved the **Decree-Law** no. 6/2016, of de 20 April, which sets out the Licensing Regime for the exploration and control of Gambling Activities

and Diversion, Gambling Machines and Traditional Games?

The Government acknowledges that gambling activities are an important "source of income for the State and can be in parallel a favorable factor for the creation and development of areas of tourist".

Until now, and even after the approval of this Decree-Law, the authorities were very conservative towards these activities. However, the Ministry of Tourism, Commerce and Industry has recently expressed the importance of these activities and that the majority of the small casinos existing in the country are already legalized.

Being a renowned attractive sector among the South East Asia nations, this step by Timor Leste shall be another important development towards diversifying the economic needs (today almost dependent of the Oil & Gas revenues).

CRA Timor has extensive experience in Casinos and Gambling matters, especially through its office in Macau, the Asia's Gambling Mecca. CRA Timor has a representative office in Macau where it deals with major Casino and gambling issues. In Timor Leste CRA Timor advises local gambling companies and follows the implementation of this Decree-Law since its very beginning.

## LEX - Global Overview on the New Regulations

Law n.º 1/2017 18 January – Transitory Regime for recruiting non Timorese Judges and Public Defenders and second amendment to Law 9/2011, 17 August, which approves the Organic of the Accounting Chambers of the Superior, Administrative, Fiscal and Accounts Court

National Parliament Resolution n.º 01/2017 of 16 January – Denunciation of the Treaty between the Government of the Democratic Republic of Timor-Leste and the Government of Australia on Certain Maritime Adjustments in the Timor Sea and Transitional Agreement regarding the validity of the Timor Sea Treaty

**Resolutions Approved by the Ministers Council:** 

The Air Services Agreement between Timor-Leste and Australia, proposed by the Minister of Foreign Affairs and Cooperation and the Minister of State, Coordinator of Economic Affairs and Minister of Agriculture and Fisheries, was approved

Approved the making of a **Draft Law on Legislative Authorization regarding business recovery and insolvency** is that the National Parliament grant to
the Government the legislative competence to approve,
by decree-law, a Recovery and Insolvency Code.

Approved the **Decree-Law of the Commercial Register** which defines the rules applicable to the legalization of companies. This document is currently under discussion in the National Parliament.

The Council of Ministers also approved the **additional subscription of shares allocated to the Democratic Republic of Timor-Leste in the International Bank for Reconstruction and Development.** 

The establishment of the national mining company, called **Murak-rai Timor-Leste, SA**, proposed by the minister of Petroleum and Mineral Resources was approved.

### Francisco Lu-Olo Guterres

Francisco Lu-Olo Guterres was elected the 6<sup>th</sup> President of Timor Leste on 20 March 2016, and shall assume office on the 20 May, the day Timor Leste celebrates 15 years as a sovereign nation, and 17 years after Lu-Olo himself read the proclamation of independence for Timor Leste after the Indonesian occupancy.

Francisco Lu-Olo Guterres was the President of the National Parliament between 2002-2007 and is one of the most respectable politicians in Timor Leste. He is also the President of FRETILIN - Frente Revolucionária de Timor Leste Independente

He won the election with 57% of votes and was already confirmed by the Court of Appeal.

CRA Timor wishes all the success to the new President as well as all the Timorese Nation and People.

- The conclusions of the discussions enriched the content of a formal submission that IBAHRI and JSMP will present to Commission A in Parliament, advocating for the revision and approval of the existing draft law for the creation of the local Bar Association. The draft law may be reviewed during the first semester of 2017


# Business Mission to Timor Leste in April


